ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 16/UT/RTI/FAA/SSP dated 25.02.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION :-

Appellant had sought information i.e. copy of DDR No. 03 dated 31.07.2021 registered at PS- IT Park along with action taken report.

COMMENTS OF CPIO/East : -

CPIO/East submitted that appellant has filed RTI application for supplying requisite information. After obtaining the requisite information from SHO-IT Park, requisite information was supplied to the appellant. Appellant has been apprised vide memo no. 40/CPIO/East dated 22.02.2022

DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had filed the instant appeal against the reply of CPIO/East with regard to sought information i.e. copy of DDR No. 03 dated 31.07.2021 registered at PS- IT Park along with action taken report

Insofar as appeal is considered, CIO/East has already supplied the sought information i.e. copy of DDR and action taken report to the appellant. Thus, CPIO/South has appropriately disposed of the RTI application, therefore, no more action is required to be taken on the instant appeal. Accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
