ORDER

The appellant has preferred his 1st appeal dated 23.02.2024 against the disposal of his RTI application dated 17.01.2024 by CPIO/South with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 19.01.2024 had sought copy of the statements given in complaint no. ICMS/2023/005276 and FIR no. 205 dated 16.12.2023 registered at PS-34, Chandigarh.

COMMENTS OF CPIO/South:-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO PS- 34 who reported that sought information pertains with case FIR No. 205 dated 16.12.2023 registered at PS-34, Chandigarh and complaint bearing no. ICMS/2023/005276, both are still under investigation/enquiry. Hence, the same was denied to the appellant as per the provisions of section 8(1) (h) of RTI Act, 2005 as FIR and complaint in question are still under investigation/enquiry. Applicant was apprised about the same vide letter No. 22/RTI-24/CPIO-South dated 31.01.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought copy of the statements

given in complaint no. ICMS/2023/005276 and FIR no. 205 dated 16.12.2023 registered at PS-34, Chandigarh.

In reply, CPIO/South denied the requisite information u/s 8(1)(h) of RTI Act as FIR and complaint are still under investigation/enquiry.

Now as far as appeal is concerned, CPIO/South has appropriately denied the sought information to the appellant as FIR and complaint in question are still under investigation/enquiry. However, to achieve the objectives of RTI Act, CPIO/South is hereby directed to provide the requisite information to the appellant as and when investigation/enquiry is completed in FIR and complaint, strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
