## ORDER

The appellant has preferred 1<sup>st</sup> appeal dated 01.02.2023 against the disposal of his RTI application dated 30.12.2022 by CPIO/South-West with the contentions that he has not been provided with his hand written document/statement given on 23.11.2022, rather provided copy of DDR.

### Information sought vide RTI application :-

The appellant vide his RTI application dated 30.12.2022 had sought information regarding an incident dated 23.11.2022 when he made a call at 100 number while standing near H. No. 6206 B, Sector 56, Chandigarh and thereafter a paper was signed by both the parties in the presence of police officials. He sought copy of that signed paper under RTI act.

#### COMMENTS OF CPIO/South-West :-

CPIO/South-West vide his comments submitted that RTI application of the appellant was received in his office on dated 06.01.2023 wherein he sought copy of statement written by I/O PP Palsora which was signed by him and and other party on 23.11.2023. Accordingly, SHO PS 39 was directed to supply the requisite information, who in reply supplied the copy of DDR No. 39 dated 23.11.2022 lodged in PP Palsora, Chandigarh in which all the contents (word to word) of statement signed by both parties were mentioned. The appellant was informed accordingly vide letter No. 05/RTI/CPIO/South-West dated 25.01.2023.

CPIO/South-West further submitted that the requisite written statement signed by both the parties was duly enclosed with the Roznamcha of dated 23.11.2022 and the same has already been sent to MM Branch, Sector 26, Chandigarh on dated 01.12.2022. At present, sought information is not available in PS Sector 39, Chandigarh.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that the information sought by the appellant relates to an incident dated 23.11.2022 and a DDR No. 39 dated 23.11.2022 was lodged in PP Palsora, Chandigarh in this regard mentioning word to word details of statement signed by both the parties. Copy of the same has already been supplied to the appellant by CPIO/South-West.

Further, it is also worthwhile to mention that Daily Dairy Register/Roznamcha of dated 23.11.2022 (containing signed statement of dated 23.11.2022 of both the parties) has already been sent to MM Branch, Sector 26 Chandigarh and the same is presently not available in the record of PS Sector 39, Chandigarh.

Hence, for the satisfaction of the appellant as well as to uphold of spirit of RTI act, CPIO/South-West is hereby directed to obtain the requisite document from the concerned branch and supply the certified copy of the same to the appellant as per RTI act. With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
