This is an order in online First Appeal bearing no. PODEP/A/E/24/00006 dated 20/01/2024, preferred Priyanka R/o 322 Durga Nagar A, Ambala City, Ambala, Haryana under RTI Act 2005, received in office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of her RTI Application bearing No. PODEP/R/E/23/01065 dated 15/12/2023 being dealt by CPIO/Trg. & Recruitment.

**Facts:-**

2. Vide RTI application dated 15/12/2023, the appellant had sought information w.r.t. recruitment of ASI (executive) in Chandigarh Police 2023, which is as under :-

*"I have appeared in Chandigarh Police ASI executive exam date of publish on 15.06.2023 date of exam 27.08.2023, roll number 2780309919, application No. 501821, candidate name Priyanka daughter of Sh. Naresh Kumar, category OBC Qualified for the PMTI have doubt about MT Tier 1 written exam Score. So kindly provide me my OMR answer sheet."*

3. The appellant, is not satisfied with the information supplied by the DSP-Cum-CPIO/Rec. & Trg against her RTI application and has filed the instant mentioning therein that *"I have appeared in Chandigarh Police ASI executive exam date of publish on 15.06.2023 date of exam 27.08.2023, roll number 2780309919, application No. 501821, candidate name Priyanka*

daughter of Sh. Naresh Kumar, category OBC Qualified for the PMTI have doubt about MT Tier 1 written exam Score. So kindly provide me question paper with code wise. My question paper booklet series was C."

4. The Comments in this appeal were sought from DSP-Cum-CPIO/Rec. & Trg, who intimated that the appellant vide her RTI application had requested to supply her OMR Sheet of ASI executive exam-2023 in Chandigarh Police and same was provided to her in time hound manner, vide office letter no. RTI-23/CPIO/Rec. & Trg. dated 16.01.2024. But the applicant filed first appeal against the disposal of her RTI application and demanding other information i.e. question paper code wise, question paper booklet, which is not mentioned in her original RTI request dated 15.12.2023.

#### **DECISION**

5. The undersigned gone through the appeal filed by the appellant viz-a-viz comments of CPIO/Trg. & Rec. From the perusal of RTI application & comments of CPIO/Trg. and Recruitment, it is found that the information sought by the applicant in her RTI application i.e. her OMR Sheet of ASI executive exam-2023 in Chandigarh Police has already been supplied to the applicant. But the instant appeal is different from the information sought in RTI application i.e. question paper code wise, question paper booklet.

Therefore, no more action is required into the matter. The appeal is hereby disposed off accordingly.
