This is an order in online First Appeal bearing no. PODEP/A/E/24/00123 dated 16/12/2024, preferred by of Sh. Ram Phal R/o H. No. 375, Manav Colony, Saketri, Panchkula, Haryana under RTI Act 2005, received in this office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/24/00900 dated 13/11/2024 by CPIO/Accounts.

Facts:-

2. Vide RTI application dated 13/11/2024, the appellant had sought information w.r.t. withdrawal of NPS Arrears, which is as under :-

"I requested for withdrawal of NPS Arrears of Rs. 35227.90 due to me for the period from 01.04.2019 to 30.09.2020 in my salary account No 50100027683207 IFSC HDFC0000597 vide my request application dated 06.09.2022 under reference. The same is still pending not yet paid to me. Action taken on the request be intimated and earliest action at your end to resolve my issue be taken please to avoid mental and financial harassment".


The said RTI application was dealt by CPIO/Accounts and same was disposed of vide no. 137/RTI/CPIO(Accounts)/2024/UT/ 338921 dated 06.12.2024.

3. The appellant, is not satisfied with the information supplied by the CPIO/Accounts against his RTI application and has filed the instant appeal mentioning therein that "I have to appeal to the Appellate Authority on the following contention please:-
1. The reply provided by your office is not satisfactory and contrary to the requisite information requested through online RTI. The reply letter of the account branch is of dated 07.04.2021 seems to be the first letter written to Treasury for final withdrawal of my NPS account and the same is already withdrawn and my NPS account is closed.
2. My request dated 06.09.2022 is of specific pending NPS arrears which was calculated later on after the final settlement of my NPS account.
3. I made a request on 06.09.2022 vide account branch receipt diary no. 11675/A dated 06.09.2022 reply of the same is still awaited.
4. I sought RTI on my earlier original request dated 06.09.2022.
5. No information has been furnished as to whether any action has been taken on it or otherwise.
6. I have to request you to take sympathetic action on my request and instruct account branch to liaise with Treasury to get it ensured that my requisite NPS arrears be credited into my account please."

4. The Comments in this appeal were sought from DSP/Hqrs-cum-CPIO/Accounts, who intimated that the appellant vide his RTI applications had requested for the action taken on his application dated 06.09.2024 regarding withdrawal of arrear in his NPS account. As intimated by concerned branch through APIO, NPS case of applicant has been sent to treasury vide their office letter no. 6906/UT/Accts/A7 dated 07.04.2021. Further, request of applicant dated 06.09.2022 was not received in concerned branch or dairy dispatch as reported by diarist.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/Hqrs-cum-CPIO/Accts. & Proc. The undersigned is of the view that the CPIO had not imposed the relevant section as per RTI Act, in the reply. Therefore, CPIO/Accounts is hereby directed to give a fresh reply to the applicant, the appeal is hereby disposed off, accordingly.
