**ORDER**

This is an order in connection with First Appeal dated 11.12.2024, preferred by Sh. Raj Singh Retd. No. 901/CP R/o House No. 60/10, Jasbir Colony, Rohtak, Haryana under RTI Act 2005, received by hand in this office, against the disposal of his RTI Application dated 19.11.2024 dealt by CPIO/Accounts & Procurement.

**Facts:-**

2. The applicant vide his RTI application dated 10.01.2024 had sought information in 05 different points pertaining to CPIO/Accounts, which are as under:-

- i) मैं C Raj Singh 901/CP सच् 30/6/2018 को Retire हुआ था मेरी Basic pay 01/01/2016 को कितनी Fix की गई है।
- ii) मुझे 6th pay commission के अनुसार नई Pension कब तक मिलेगी और इस पर अभी क्या कार्यवाही चल रही है।
- iii) मैं 25/05/2000 को भर्ती हुआ और 30/6/2018 को रिटायर हुआ (18 वर्ष सर्विस) जबकि मेरी Pension 6491/- है और C Balram 3454/CP जो 16/7/2003 मे भर्ती हुआ और 31/12/2019 को रिटायर हुआ (16 वर्ष 5 महीने) जिसकी pension 14289/ रुपये है। कृपा इसका हवाला दिया जाए। मेरी Pension कम क्यों है।
- iv) पेंशन निकालने का पूरा formula दिया जाए जो CCS, Pension Rule 2021 है w.e.f 1/4/22 इसका हवाला दिया जाए ।
- v) RTI Act 2005 की u/s 2 (f) का पूरा विवरण दिया जाए।




3. The appellant is not satisfied with the information supplied by the CPIO/Acct. & Proc. vide no. 139/RTI/CPIO(Accts)/2024/UT/32427 dated 02.12.2024, against his RTI application dated 19.11.2024 and has filed the instant appeal alleging therein that Mr. Satish pushed him out form pension branch and told him that no one would be do his work.

4. The Comments of CPIO/Accounts & Proc. were sought vide this office letter no. D-949/RTI/SP/Hqrs/UT dated 12.12.2024, who has intimated that the information sought by the applicant in point 5 points out of which point nos. 1,2 and 3 could not be provided as the revised pension case along with the original service book of the applicant has been sent to AG Office Chandigarh and reply against the point nos. 4 & 5 was provide to applicant within the stipulated time, vide no. 139/RTI/CPIO (Accts)/2024/UT/32427 dated 02.12.2024.

5. The appeal was fixed for hearing on 23.12.2024 at 10.00 AM, both the CPIO as well as Dealing hand (pension branch) were directed to appear before the undersigned with relevant record and the Appellant was also request to afforded the opportunity during hearing, but he did not attend the same.

#### DECISION

6. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/Hqrs-cum-CPIO/Accts. The undersigned is satisfied with the reply/comment submitted by the CPIO/Accounts, stating that the information regarding point nos. 1 to 3 could not be provided, as the revised pension case, along with the service book of the applicant, has been forwarded to the AG office on the request of applicant. Further, the information w.r.t. points 4 and 5 is available in the public domain. Therefore, no further action is required in this matter, and the appeal is hereby disposed of accordingly.
