ORDER

The appellant has preferred 1st appeal dated 06.02.2023 against the disposal of his RTI application bearing dated 22.12.2022 by CPIO/Central with the contentions that no information has been provided to him, rather advised to file an appeal.

Information sought vide RTI application :-

The appellant vide his RTI application dated 22.12.2022 had sought information on 2 points pertaining to an incident of dated 08.08.2015 when his wife Harneet with her maternal uncle along with the police party in a police jeep raided his college i.e. PGGCG Sector 42 Chandigarh and picked him from the college premises and brought him to the Police Post Sector 22 Chandigarh. Appellant vide his RTI application dated 22.12.2022 sought (1) Action taken report in the above case (2) Provide all documents related with this case.

COMMENTS OF CPIO/ Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office on dated 22.12.2022 to supply the information on 2 points pertaining to an incident of dated 08.08.2015. Accordingly, the requisite information was sought from SHO PS 17, who reported that the Daily Diary/Roznamchas and relevant/attached documents for dated 08.08.2015 had been deposited in VRK Branch, Police Line sector-26 Chandigarh and the same had been destroyed vide order No. OB-

171/2018. Hence the requisite information could not be supplied. This reply was further conveyed to the appellant vide letter No. 347/RTI-22/CPIO-Central/UT/dated 17.01.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the information sought by the appellant relates to an incident dated 08.08.2015 and relevant official record i.e. Daily Dairy/Roznamchas and attached documents with DDRs of this period has already been destroyed vide order No. OB-171/2018. As the record pertaining to requisite information was not available, hence the same could not be supplied.

As the appellant has already been informed about all the available facts in the matter by CPIO/Central and there is no denial to the information on the part of CPIO, so, no more action is requires to be taken in the matter. With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
