Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/23/00015 dated 14/02/2023, preferred by Sh. Satish Kumar R/o # 4255, Sector-46 D, Chandigarh, under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/22/00990 dated 14/12/2022 by CPIO/Establishment.

- (2) The appellant, vide his application dated 14/12/2022 under RTI Act 2005, had requested CPIOs to supply him some information in 05 points related to recruitment in 1987 by Chandigarh Police in Communication Wing. Nodal Officer/PHQ has transferred the application to DSP-cum-CPIO/Establishment for its proper disposal. CPIO/Establishment disposed of the RTI application on 10/01/2023, vide No. 227/RTI-22/CPIO(Estt.)/UT 1451.
- (3) The appellant, not satisfied with the information supplied by the CPIO against his RTI application and has filed the instant online appeal to provide right information.
- (4) Comments of CPIO have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment.
