



**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-  
COMMUNICATION, UNDER RIGHT TO INFORMATION ACT, 2005.**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on First Appeal dated 13.05.2024, preferred by Sh. Vijay Kumar R/o House No. 3233, Sector-47/D, Chandigarh, under RTI Act 2005, received in this office through speed post, against the disposal of his RTI Application dated 16.04.2024 by CPIO/Communication.

(2) The appellant, vide his application dated 13.05.2024 under RTI Act 2005, had requested CPIO, Sr. Supdt. of Police to supply him some information in 03 points regarding an emergency call made by him on helpline No. 112 dated 05.04.2024 at 7:45 PM which was marked to CAPIO/PHQ. Incharge, Public Window (PHQ)-cum-CAPIO, further transferred the RTI application to CPIO/Comm and CPIO/South vide No. 358/RTI/CAPIO(PHQ)/UT/PWS dated 18.04.2024, for disposal at their own level being custodian of information. The point no. 1 of his RTI application was dealt by CPIO/Communication and points nos. 2 & 3 were dealt by CPIO/South. The appellant is not satisfied with the manner CPIOs had disposed of his RTI application, filed the instant appeal alleging that all the CPIO/Commn. has provided incomplete, misleading or false information and no reply is received from CPIO/South, so far.

(3) The comments of CPIO/Communication have been called for. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO. The points-wise decision of the undersigned being first appellate authority w.r.t. CPIO/ Communication is as under:-

<b>Gist of RTI application</b>			
I have made an emergency call on Number 112 dated 05.04.2024 at 7.45 pm, for safety to the life, and threatening to kill by the civil contractor demolishing and constructing the H. No. 3233/1, Sector 47-D, upper storey flat, due to unprotected demolition, roof lantern and walls has emerged cracked the water was flowing on our the beds and not safe to live in the GF house. The vehicle CH01GA6684 has visited at site and was shown the water leakage on my bed due to cracks in the roof lantern, and malba lying in our front and rear courtyard by above story flat owner. The matter was handed over by the officer of PCR to PS 31 to take further action in the matter. The police officer visited from sector 31 police station and was shown the actual situation. A written Complaint was also handed over to the police officer visited on the spot.

At 2105 Hrs, Incharge PCR vehicle HC Jai Bhagwan No. 1786/CP told that Complainant Vijay Kumar R/O H.No. 3233 Sector 47/D, Chandigarh against a lady namely Anama By Ju age 48 years R/O H.No. 3233/1 Sector- 47/D, Chd. Spot handed over HC Ajmer Singh No. 1879/CP PS-31 at 2058 hours.	<b>Point No. 1:-</b> The reply/ information provided by CPIO against the Point No. 1. is not as per his RTI Application, in which he requested to provide the certified copy of report submitted by the PCR officer.	CPIO/Communication is hereby directed to provide a certified copy of report submitted by PCR officer.

<b>Point No. 2</b> Kindly provide me the certified copy of my complaint dated 05/04/2024 handed over to the police officer of PS 31, along with photographs taken of the site by the police officer of leakages of water from the roof on my bed.	<b>Point No. 2 and 3 were dealt by CPIO/South</b>	<b>Point No. 2 &amp; 3:-</b> The reply against the point nos. 2 & 3 are still awaited.	<b>Point No. 2 &amp; 3:-</b> The appeal w.r.t. point Nos. 2 & 3 is hereby transferred to SSP/UT-being First Appellate Authority w.r.t. SDPO-cum-CPIO/South, for part disposal.
<b>Point No. 3</b> Kindly provide me the action taken report on my complaint, handed over to the police officer of PS 31 and copies statements recorded by the police officer.			

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
