This is an order in connection with First Appeal under RTI Act , preferred by of Sh. Avtar Singh R/o # 66, PSIEC Colony Sector- 74, Mohali, Punjab under Section 19(1) of RTI Act-2005, received by hand in this office being dealt by CPIO/Accounts, against the disposal vide bearing No. 86/RTI/CPIO (Accts)/2023/UT/36326 dated 14.08.2023.

Facts:-

- 2. Vide RTI application dated 26.07.2023, the appellant had sought information in 10 different points pertaining to CPIO/Accounts & Proc & CPIO/Establishment, which are as under:-
 - 1) Benefits of retirement are giving me form which date?
 - 2) Benefits of annual/five years increments are giving me from which date?
 - 3) Benefits of LTC are giving me from which date?
 - 4) Benefits of new pay scales as per chart?
 - 5) Proposed benefits as per new pay/pension benefits?
 - 6) Proposed date on which pension benefits will be paid and date of its applicable.
 - 7) In case of delay to applicable benefits, I have to right it get it with interest applicable.
 - 8) Name & Designation of officials responsible to implement?
 - 9) Weather the officials responsible to implement new pay scale are enjoying these benefits or not?
 - 10) If receiving official has no information, my application to sent to concern official as per RTI Act.

- 3. The appellant is not satisfied with the information supplied vide no. 86/RTI/CPIO (Accts)/2023/UT/36326 dated 14.08.2023 by the CPIO/Acct. & Proc. against his RTI application and has filed the instant appeal mentioning therein that " 1. Sr. 2 and 3. Of my application no information provided to me. 2. I want to clarifying that I seeks information regarding implementation of revised pension benefits after receiving letter no. 65-1-34-UT F II (12) 2022/11635 dt. 04.08.2022 (status report) as per serial no. 06. 3. Similarly point no. 8 and 9 found unanswered.
- 4. The Comments of CPIO/Accounts & Proc. and CPIO/Establishment were sought, vide No D-736/RTI/SP/Hqrs. dated 08.09.2023. CPIO/Accounts & procurement intimated that point-wise reply of the RTI application supplied to the appellant within stipulated time period vide no. 86/RTI/CPIO (Accts)/2023/UT/36326 dated 14.08.2023, whereas, CPIO/Establishment had transferred the same application to CPIO/Account to dispose the same at her own level, vide no. 156/RTI/23/CPIO/Estt/UT/32725 dated 04.08.2023.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Accts. & Proc & Establishment. From the perusal of appeal, the undersigned found that the appellant has mentioned that some points of the RTI application were undealt i.e. 2,3,8 & 9.

In the view of above, CPIO/Accts. & Proc is hereby directed to supply a fresh reply w.r.t. points no. 2,3,8 & 9 to the appellant, under the intimation to this office. The appeal is hereby disposed of, accordingly.
