ORDER

The appellant has preferred 1st appeal dated 25.11.2022 against the disposal of his RTI application dated 27.09.2022 by CPIO/Central with the contentions that information requested has been refused to him.

Information sought vide RTI application :

The appellant vide his RTI application dated 27.09.2022 had sought page wise enquiry report along with noting etc on his application dated 01.06.2022 addressed to SSP UT Chandigarh. The matter pertains to complaint bearing PWS No. 2022-12157.

Comments of CPIO/Central :-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office through CAPIO/PHQ vide his office No. 851/RTI/CAPIO(PHQ)/UT/PWS, dated 29.09.2022. Thereafter, requisite information was sought from SHO PS Sector 3, Chandigarh who reported that complaint bearing PWS No. 2022-12157 was pending under enquiry, hence the requisite information could not be supplied and the same was denied U/S 8(1)(h) of RTI act. Applicant was informed accordingly through registered post vide letter No. 270/RTI-22/CPIO-Central, dated 26.10.2022.

So far as the present status of the complaint bearing PWS No. 2022-12157 is concerned, enquiry into this complaint is completed and the same has been sent to senior officer for finalization.


Decision :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that at the time of disposing of the RTI application of the appellant, complaint bearing PWS No. 2022-12157 was pending under enquiry, hence the requisite information was rightly denied by CPIO/Central U/S 8(1)(h) of RTI act.

So far as the present status of the complaint bearing PWS No. 2022-12157 is concerned, enquiry into this complaint is completed and the same has been sent to senior officer for finalization. Henceforth CPIO/Central is hereby directed to supply the requisite information to the appellant as and when enquiry into this complaint is finalized, **as per RTI Act.**

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
