ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 04/UT/RTI/FAA/SSP dated 18.01.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copy of complaint filed against her along with other documents.

COMMENTS OF CPIO/South: -

Comments of CPIO/South was obtained who submitted that report from SHO/PS-39 obtained who submitted that appellant wants information pertaining to complaint bearing No. 2020-15040 and the same were under enquiry, therefore, the same was denied u/s 8(1)(h) of RTI Act.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copy of complaint filed against her along with other documents.

Insofar appeal is concerned, it is clear that appellant wants copy of complaint bearing 2020-15040 filed against her which is under enquiry at present. Copy of complaint can be supplied to the appellant being alleged party in the complaint. Hence, CPIO/South has wrongly applied section 8(1)(h) of RTI Act as by supplying the copy of complaint would not impede the process of enquiry.

In view of above, CPIO/South is hereby directed to supply the copy of complaint free of cost, forthwith to the appellant. Accordingly, instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
