ORDER

The appellant has preferred 1st appeal against the reply of CPIO/East in connection with her RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 31/UT/RTI/FAA/SSP dated 29.03.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 12 points pertaining to case FIR No. 43/2021, PS-19, UT, Chandigarh i.e. Copy of MLC of the appellant, her mother Mrs. Laxmi Devi, Copy of re-medical of both, time of medical examinations, Name and designation of Doctors during both medical examinations, names of Police personnel who conducted medical examinations etc.

COMMENTS OF CPIO/East : -

CPIO/South submitted that appellant has sought information through online RTI application. After obtaining report from SHO/PS- I/A & 19, appellant was informed vide No. 194/CPIO/South dated 30.04.2021 that information sought vide point 01-10 cannot be supplied and denied u/s 8(1)(h) of RTI act. The Challan in the instant case FIR no. 43/2021, PS-19, has already been submitted in the learned Court on 22.02.2022 and the same is under trial, hence record in question is not available with local police. As far as point 11 & 12 are concerned, information has already been supplied to the appellant.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that CPIO has denied the information pertaining to point nos. 01 to 10 with regard to MLC and doctors who conducted Medical examinations. However, information related to point nos. 11-12 i.e. names of police officials, was supplied to the appellant.

Now, as far as the appeal is concerned, CPIO has submitted that challan in the case in question, has already been submitted before the Learned Court, so the requisite information can be sought from Learned Court. However, keeping in view the interest of justice, CPIO/East is hereby directed to arrange the inspection of the

relevant record of police station and supplied the available information to the appellant as per RTI act.

Moreover, appellant is also advised to contact the concerned Learned Court for obtaining remaining information pertaining to point nos. 01 to 10, if any.

With these directions, appeal stand disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
