**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 21/UT/RTI/FAA/SSP dated 14.03.2022 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION :-**

The appellant had sought information on 05 points i.e. copy of action taken report on complaint filed by the appellant in Police Complaint Cell, information regarding the relevance of Chandigarh Police Complaint 2016 with Haryana Police Complaint 2018, copy of statements submitted by I.O. from Oct. 2016 to 23 Feb. 2018, no. of complaints closed by I.O. on basis of Whatsapp/telephone messages during last 07 years etc.

**COMMENTS OF CPIO/East :-**

CPIO/East submitted that appellant has sought information through online RTI application. After obtaining report from SHO/PS- 26, point wise reply was supplied to the appellant vide memo no. 61-RTI/CPIO/East/Dated, Chandigarh, the: 08.03.2022.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought information on 05 points i.e. copy of action taken report on complaint filed by the appellant in Police Complaint Cell, information regarding the relevance of Chandigarh Police Complaint 2016 with Haryana Police Complaint 2018, copy of statements submitted by I.O. from Oct. 2016 to 23 Feb. 2018, no. of complaints closed by I.O. on basis of Whatsapp/telephone messages during last 07 years etc.

Now, as far as the appeal is concerned, point nos. 02 to 05 are concerned with CPIO/East and he has supplied the available information to the appellant. Moreover, it is also pertinent to mention that appellant has sought very vague information without providing any specific details which is very difficult to understand and comply. Accordingly, the instant appeal is filed as "dismissed".

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
