ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 26/UT/RTI/FAA/SSP dated 23.03.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information regarding DDR no. 37 dated 03.02.2015, PS-39, Chandigarh.

COMMENTS OF CPIO/South: -

CPIO/South submitted that application of the appellant was received for supplying requisite information and report from SHO-39 was obtained, who reported that DDR (Roznamcha) of year 2015 has already been destroyed vide OB no. 145/19. Appellant was informed in this regard vide letter No. RTI-73/CPIO-South dated 19.03.2022.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information regarding DDR no. 37 dated 03.02.2015, PS-39, Chandigarh.

Insofar as appeal is concerned, the requisite information is seven (07) years old hence, CPIO/South already informed the appellant that Daily Diary

Register of year 2015 has already been destroyed and not available in record. However, considering the appeal of the appellant, CPIO is hereby directed to provide copy of order vide which DDR no. 37 dated 03.02.2015 was destroyed and also supply copy of above said DDR and other relevant documents about the action taken on it, if available in CCTNS record, as per RTI Act. It is also pertinent to mention here that only available information can be supplied under RTI Act, hence, only available information with CCTNS can be supplied to the appellant. With these directions, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
