ORDER

The appellant has preferred 1st appeal through online RTI portal vide no. PODEP/A/E/22/00043 dated 25.04.2022 against the reply/order of CPIO/Central in connection with her RTI application dated 30.03.2022 with the contentions that requisite information was not supplied to him.

## INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information pertaining to her complaint no. 2022-06553 dated 30.03.2022 regarding carrying of two alive pigs in an auto by unknown persons in forceful manner.

## COMMENTS OF CPIO/CENTRAL : -

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00224 dated 30.03.2022. Thereafter, report from SHO PS Sector 11 was obtained and the appellant was informed vide letter no. 78/RTI-22/CPIO-Central/UT dated 16.04.2022 that the requisite information could not be supplied to her as the complaint bearing no. 2022-06553 dated 30.03.2022 was under enquiry at that time. Hence the information was denied u/s 8(1)(h) of RTI act. Moreover, as far as present status of the complaint is concerned, enquiry has been conducted and no cognizable offence has been made out. Copy of DDR No. 23 dated 14.04.2022 has also been provided to the appellant through special messenger.

## **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that requisite information could not be supplied to the appellant as the complaint in question i.e. bearing no. 2022-06553 dated

30.03.2022 was under enquiry at that time. Hence the information was denied u/s 8(1)(h) of RTI act. Moreover, as far as present status of the complaint is concerned, enquiry has been conducted and no cognizable offence has been made out. Copy of DDR No. 23 dated 14.04.2022 has also been provided to the appellant through special messenger. Final decision on the complaint is yet to be taken.

In view of above, available information has already been supplied to the appellant but complete enquiry report and other relevant documents can be supplied after finalization of complaint. Hence, CPIO/Central is hereby directed to cooperate with the appellant and supply the requisite information to her after finalization of the complaint, if she approaches for the same.

With these directions, appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
