ORDER

The appellant has preferred 1st appeal through RTI portal vide no. PODEP/A/E/22/00020 dated 17.03.2022 which was received in the office of the undersigned on 08.04.2022 from the O/o FAA-Cum-SP/Accounts & PEB only w.r.t. point nos. 01 & 02 dealt by CPIO/IRB in connection with his RTI application dated 12.02.2022.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 06 points out of which only two points i.e. point nos. 01 & 02 were dealt by CPIO/IRB i.e. How many police officials were sent for election duty in Pondicherry in April, 2021 and Provide the date of departure and arrival of these police personnel.

COMMENTS OF CPIO/IRB : -

Comments of CPIO/IRB have been obtained who submitted that RTI application of the appellant was received in his office on 15.02.2022 through online RTI portal vide no. PODEP/R/E/22/00100/1 and from CPIO/PEB vide no. RTI-02/PEB Br. Dated 21.02.2022. Thereafter, requisite

information was sent to the appellant vide letter no. 04(A)-1/RTI/DSP (Admn.)-cum-CPIO (IRB) dated 03.03.2022.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/IRB vis-à-vis material available on record which revealed that RTI application was dealt by CPIO/IRB only related to two points i.e. point nos. 01 & 02 and he has supplied the complete information to the appellant.

Moreover, appellant has also not mentioned any grievance regarding CPIO/IRB in his 1st appeal.

Hence, no more action is required to be taken on the instant appeal, the same stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
