ORDER

The appellant has preferred 1st appeal through RTI portal vide no. PODEP/A/E/22/00036 dated 13.04.2022 in connection with disposal of his RTI application dated 21.02.2022 by CPIO Central.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant has sought copies of all statements, status of legal opinion and all relevant documents in connection with enquiry of complaint bearing PWS no. 2019-19815 dated 16.10.2019.

COMMENTS OF CPIO/Central: -

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received in his office on 17.03.2022 through online RTI portal vide no. PODEP/R/E/22/00119 dated 21.02.2022. Thereafter, requisite information was obtained from SHO PS 17 and as per his report, after completing the enquiry in complaint bearing PWS No. 2019-19815, the same was sent to senior officers for consideration. As the enquiry into the complaint was not finalized so the requisite information was denied u/s 8(1)(h) of RTI act and the appellant was informed accordingly vide letter dated 22.03.2022.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the information sought by the appellant pertains to compliant bearing PWS No. 2019-19815 and the same was under consideration while disposing RTI application of the appellant. Hence, the information was rightly denied by the CPIO/Central u/s 8(1)(h) of RTI act.

So far as present status of the complaint is concerned, some points/facts are surfaced and required to be re-examined. Hence, the compliant has been sent to SDPO/Central to re-examine the facts and submit report expeditiously.

However, CPIO/Central is directed to supply the requisite information to the appellant as per RTI act as and when enquiry into the complaint is finalized.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
