ORDER

The appellant has preferred 1st appeal through online RTI portal vide No. PODEP/A/E/22/00146 dated 09.12.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00734 dated 20.09.2022 with the arguments that no response has been given to him within the time limit.

Information sought vide RTI application:

The appellant vide his RTI application dated 20.09.2022 had sought information pertaining to enquiry of complaint bearing PWS No. 2021-17223 filed by him regarding accident case of his wife.

Comments of CPIO/South:-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/22/00734 dated 20.09.2022. Thereafter, after checking the office records, the requisite information was denied to the applicant vide letter No. 312/CPIO/South, dated 03.10.2022 attracting section 8(1)(h) of RTI act as the complaint bearing PWS No. 2021-17223 was pending under consideration with his own office at that time.

Decision:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that at the time of disposing of the RTI application of the appellant, the complaint bearing PWS No. 2021-17223 was pending under consideration with SDPO-cum-CPIO/South and supplying of information at that stage would impede the process of enquiry, so the requisite information pertaining to this complaint was rightly denied by CPIO/South u/s 8(1)(h) of RTI act. So far as the present status of this complaint is concerned, as per record, enquiry into the same is yet to be finalized.

Henceforth, for achieving the objective of RTI Act as well as for satisfactions of the appellant, CPIO/South is hereby directed supply the requisite information to the appellant as and when the enquiry into the complaint bearing PWS No. 2021-17223 is finalized, as per RTI Act.

With these directions, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
