ORDER

The appellant has preferred his 1st appeal dated 17.04.2023, received on 20.04.23 through post and on dated 24.04.23 from Chandigarh Admn. against the disposal of his RTI applications dated 16.01.2023, received on 21.02.23 & on 10.03.23 from Chandigarh Admn. by CPIO/Central and Hqrs with the contentions that investigation reports on his various letters were not supplied to him and appropriate action was not taken on his letters/requests.

Information sought vide RTI application :-

The appellant vide his RTI applications dated 16.01.2023, received on 21.02.23 & on 10.03.23 from Chandigarh Administration had sought the action initiated along with noting sheet on file with regard to following letters :-

1. Letter No. 27211/AK/18 dated 12.05.2017
2. Letter No. 27211/AK/27 dated 06.12.2017
3. Letter No. 27211/AK/29 dated 14.03.2018

COMMENTS OF CPIO/Central :-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office from CPIO/Hqrs vide letter No. 91/CPIO/Hqrs/RTI-23/D-124 dated 22.02.2023. Thereafter, requisite information was obtained from SHO PS Sector 17, Chandigarh and who reported that letter Nos. 27211/AK/18 dated 12.05.2017, 27211/AK/27 dated 06.12.2017 & 27211/AK/29 dated 14.03.2018 were attached with complaints Nos. 2018-00704 dated 12.01.2018, 2019-01963 dated 04.02.2019 and 2020-03592 dated 24.02.2020 respectively. These complaints have already been consigned to record after completion of enquiry. Hence, RTI application was transferred to CPIO/Hqrs vide letter No. 50/RTI-23/CPIO/Central/UT dated 18.03.2023 under intimation to the undersigned.

Comments of CPIO/Hqrs :

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from Superintendent (Police)-Cum-CPIO, Chandigarh Administration

Secretariat and from Superintendent (R&J)-Cum-CPIO, Chandigarh Administration Secretariat vide Nos. 44(RTI)-CPIO-HIII(2)-2023/2576 dated 21.02.2023 and 7 & 8/RTI/2023/R&J-2023/3408 & 3410 dated 10.03.2023 respectively. Thereafter, requisite information was obtained from concerned branch i.e. HAC and the same (consisting of 33 pages) was supplied to the appellant vide letter No. 91/CPIO/Hqrs/RTI-2023/D-206 dated 22.03.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central & Hqrs. vis-à-vis material available on record which revealed that the appellant had sought action taken on the letter Nos. letter Nos. 27211/AK/18 dated 12.05.2017, 27211/AK/27 dated 06.12.2017 & 27211/AK/29 dated 14.03.2018.

In reply, CPIO/Central had transferred the RTI application to CPIO/Hqrs (being custodian of information) as letter Nos. 27211/AK/18 dated 12.05.2017, 27211/AK/27 dated 06.12.2017 & 27211/AK/29 dated 14.03.2018 were attached with complaints Nos. 2018-00704 dated 12.01.2018, 2019-01963 dated 04.02.2019 and 2020-03592 dated 24.02.2020 respectively and these complaints have already been consigned to record after completion of enquiry.

Thereafter, CPIO/Hqrs obtained the requisite information from quarter concerned and the same (consisting of 33 pages) was supplied to the appellant as per RTI act.

So far as the appeal is concerned, the matter is primarily related to Case FIR No. 347 dated 06.09.2016 u/s 341, 332, 353, 354 D, 34 IPC registered in PS Sector 17, Chandigarh and the challan has been presented before the learned Court on 29.07.2017. The appellant, through instant appeal, has raised many grievances regarding the enquiries of his aforementioned letters/complaints of the year 2016, 2017 & 2018 etc. and the conduct of the then police officials during the investigation of the afore said case which is altogether a different matter. Moreover, the available information on record has already been supplied to the appellant. Regarding his redressal, he should approach competent authorities. Under RTI act, only available information can be supplied to the appellant. With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
