ORDER

The appellant has preferred 1st appeal dated 06.04.2023 against the reply/order of CPIO/Central in connection with his RTI application dated 07.03.2023 with the contentions that requisite information was not supplied to him.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 07.03.2023 had sought copies of DDRs/FIRs lodged against the appellant in Police Post Sector 22 and Police Station Sector 17 from 1st January, 2006 to 28th February, 2023.

COMMENTS OF CPIO/Central : -

CPIO/Central submitted that application of the appellant was received in his office by hand on 07.03.2023 for supplying requisite information. Thereafter, requisite information was obtained from SHO PS-17 who reported that as per record case FIR No. 222 dated 30.05.2016 u/s 325, 34 IPC PS-17 and a Kalandra vide DDR No. 62 dated 09.02.2023 u/s 107/151 CrPC PS-17 were found lodged against the appellant. Copies of above said FIR and Kalandra were provided to the appellant vide letter No. 61/RTI-23/CPIO-Central/UT dated 03.04.2023. It has also been informed to the appellant that "roznamchas" before the year 2021 of Police Post Sector 22 have already been destroyed.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought copies of DDRs/FIRs lodged against the appellant in Police Post Sector 22 and Police Station Sector 17 from 1st January, 2006 to 28th February, 2023.

In reply, CPIO/Central provided the copies of case FIR No. 222 dated 30.05.2016 u/s 325, 34 IPC PS-17 and a Kalandra vide DDR No. 62 dated 09.02.2023 u/s 107/151 CrPC PS-17 to the appellant. It has also been informed to the appellant that "roznamchas" before the year 2021 of Police Post Sector 22 have already been destroyed.

Insofar as appeal is concerned, appellant has sought destroyed information before the year 2021 which is not possible to provide as the same is not existed in record. However, the copy of order vide which the said record was destroyed, can be supplied.

Hence, CPIO/Central is hereby directed to supply the copy of destroyal order, free of cost, to the appellant. With these observations, instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
