ORDER

The appellant has preferred 1st appeal dated 05.04.2023, received in this office from Addl. Superintendent-cum-CPIO, Model Jail, Chandigarh on 13.04.2023 against the disposal of his RTI application dated 01.10.2022, received on 24.11.2022 by CPIO/Hqrs with the contentions that requisite information was not supplied to him.

Information sought vide RTI application :

The appellant vide his RTI application dated 01.10.2022, received on 24.11.2022 had sought information on 04 points i.e. copy of complaint filed by Mr. Chander Parkash Pandey against the appellant in September and December, 2021, copy of final outcome of complaint, copy of compromise between Chander Parkash Pandey and the appellant and details of all complaints filed against appellant at Public Window System from 2020 to till date.

Comments of CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from Addl. Supdt., Model Jail, Chandigarh vide No. 8750/UT/AIG/CHD dated 24.11.2022. Accordingly report from I/C PWS (Public Window System) was obtained who reported that only one complaint was found received against the appellant i.e. 27571/2021. Accordingly, requisite information was obtained from I/C HAC and the appellant was informed to collect the requisite information vide letter No. 749/CPIO/ Hqrs/RTI-22, D-1153 dated 27.12.2022 or send the requisite fee under RTI act. Then after receipt of requisite fee under RTI act on 27.03.2023, sought information was sent to the appellant in the shape of (10) ten pages vide letter No. 749/CPIO/ Hqrs/RTI-22, D-219 dated 27.03.2023.

Decision :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant had sought information on 04 points i.e. copy of complaint filed by Mr. Chander Parkash Pandey against the appellant in September and December, 2021, copy of final outcome of complaint, copy of compromise between Chander Parkash Pandey and the appellant and details of all complaints filed against appellant at Public Window System from 2020 to till date.

In reply, CPIO/Hqrs., after obtaining the requisite information from quarter concerned, informed the appellant to collect the requisite information from his office or send the requisite fee under RTI act. Then after receipt of requisite fee under RTI act on 27.03.2023, sought information was sent to the appellant in the shape of (10) ten pages. However, with regard to point No. 03 i.e. copy of compromise between Chander Parkash Pandey and the appellant & relevant DDRs in the year 2021, CPIO/Hqrs should transfer the RTI application to CPIO/South but he did not transfer the same.

So far as appeal is concerned, CPIO/Hqrs has already provided the available information to the appellant. But to uphold the spirit of RTI act, CPIO/Hqrs is hereby directed to transfer the RTI application to CPIO/South with immediate effect for relevant points and offer the inspection of the relevant complaint file to the appellant personally or through his authorized representative and supply the remaining information, if any as per RTI act. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
