The appellant has preferred 1<sup>st</sup> appeal against the disposal of his online RTI application bearing No. PODEP/R/E/23/00266 dated 05.04.2023 by CPIO/East with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application dated 05.04.2023 had sought status report regarding his complaints Nos. ICMS/2022/011504, 011839, 011640, 011628, 015056 & ICMS/2023/005257, 007273 and 007799.

**COMMENTS OF CPIO/East :-**

CPIO/East. vide his comments submitted that RTI application was received in his office through online RTI portal bearing No. PODEP/R/E/23/00266 dated 05.04.2023 to obtain information regarding his complaints. Accordingly, requisite information was obtained from SHO PS Sector 26 who reported that complaints in question have been sent to I/C CRU after inquiry for finalization and the appellant was apprised accordingly vide letter No. 90-RTI/CPIO/East/ Dated, Chandigarh the 22.04.2023.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought status report regarding his eight (08) complaints bearing Nos. ICMS/2022/011504, 011839, 011640, 011628, 015056 & ICMS/2023/005257, 007273 and 007799.



In reply, CPIO/East after obtaining the requisite information from SHO PS Sector 26, appraised the appellant about the status of his complaints.

As far as the instant appeal is concerned, appellant has only sought the status of his complaints which was duly provided by CPIO/East. So far as the present the status of the complaints are concerned, it has been confirmed from the record of Public Window that the same are still under consideration/enquiry for finalization. However, in the interest of justice and to uphold the spirit of RTI act, CPIO/Hqrs is hereby directed to supply the available information related to the complaints of the appellant to him in accordance with RTI act as and when the same will be finalized.

With these observation the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
