The appellant has preferred his 1st appeal against the disposal of his RTI application by CPIO/Hqrs with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information regarding Case FIR No. 163 dated 24.05.2017 PS Sector 31 and complaint bearing No. PW2017-01516 dated 08.02.2017 i.e. what section of IPC was imposed in FIR No. 163 dated 24.05.2023 in respect of complaint No. PW2017-01516.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from I/C Public Window vide No. 326/RTI/CAPIO/PHQ/PWS dated 18.04.2023 to obtain information regarding case FIR No. 163 dated 24.05.2017 PS Sector 31 and complaint bearing No. PW2017-01516 dated 08.02.2017. Thereafter, requisite complaint file was obtained from HAC branch and the inspection of the same was offered to the appellant, but he refused to collect the available information. However, appellant was duly apprised vide letter No. 209/CPIO/Hqrs/RTI-2023, D-323, dated 01.05.2023 that case FIR No. 14 dated 08.01.2016 u/s 452, 307 IPC and case FIR No. 163 dated 24.05.2017 u/s 341, 354 D, 506, 34 IPC & 67 IT Act were registered in PS Sector 31 in this matter.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant has sought information regarding Case FIR No. 163 dated 24.05.2017 PS Sector

31 and complaint bearing No. PW2017-01516 dated 08.02.2017 i.e. what section of IPC was imposed in FIR No. 163 dated 24.05.2023 in respect of complaint No. PW2017-01516.

In reply, CPIO/Hqrs after obtaining the relevant file from HAC Branch, offered the inspection of the same to the appellant but he refused to collect the available information. However, appellant was duly apprised that case FIR No. 14 dated 08.01.2016 u/s 452, 307 IPC and case FIR No. 163 dated 24.05.2017 u/s 341, 354 D, 506, 34 IPC & 67 IT Act were registered in PS Sector 31 in this matter.

So far as appeal is concerned, CPIO/Hqrs has already provided the available information to the appellant and ample opportunity has also been provided to the appellant to inspect the relevant complaint file and collect the requisite information, but he refused to received the same on his own level. So, there is neither any delay nor any denial on the part of CPIO. Hence, no more action is required to be taken on the instant appeal. With these observations, appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
