ORDER

The appellant has preferred her 1st appeal dated 13.08.2024 against the disposal of her RTI application dated 20.07.2024 by CPIO/East with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought information on 02 points regarding FIR No. 374 dated 21.09.2015 registered at PS-26, Chandigarh regarding murder of Sh. Sukhmanpreet Singh Sidhu alias Sippy Sidhu i.e. copy of statements recorded and copy of evidence/documents collected.

COMMENTS OF CPIO/East:-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO-26 who reported that FIR No. 374 dated 21.09.2015 registered at PS-26, Chandigarh has already been transferred to CBI for further investigation vide order no. 1521/3(04CS)/2016/CBI/SCB/CHG dated 13.04.2016. Applicant was apprised about the same vide letter No. 111-RTI/CPIO/East dated 13.07.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information 02 points regarding FIR No. 374 dated 21.09.2015 registered at PS-26, Chandigarh regarding murder of Sh. Sukhmanpreet Singh Sidhu alias Sippy Sidhu i.e. copy of statements recorded and copy of evidence/documents collected.

In reply, CPIO/East has apprised the appellant that FIR No. 374 dated 21.09.2015 registered at PS-26, Chandigarh has already been transferred to CBI for further investigation vide order no. 1521/3(04CS)/2016/CBI/SCB/CHG dated 13.04.2016, hence, requisite information could not supplied to him and the same may be obtained from the concerned SPIO.

So far as the appeal of the appellant is concerned, the appellant has already been apprised by CPIO/East that FIR in question, has already transferred to CBI for further investigation, so, she should approach the concerned SPIO for requisite information as requisite information is currently not under the custody of CPIO/East.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
