ORDER

The appellant has preferred 1st appeal on dated 27.06.2022 against the reply/orders of different CPIOs in connection with his RTI application dated 25.05.2022 with the argument that incomplete and false information has been provided to him.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 25.05.2022 had sought information on 4 points regarding FIRs/ DDRs registered against Akshay Sharma @ Kukku Sharma, Parvesh Sharma @ Shanu Sharma, Nimmi Sharma and Sarv Moham Sharma all R/O H. No. 1224, Sector 39-B, Chandigarh for the period January 2010 to May 2020.

As reply of RTI application of all the above said 6 CPIOs have been attached by the appellant himself alongwith his 1st appeal in which only CPIO/ South-West supplied the requisite information and rest of the CPIOs replied that no FIR/DDR found registered against the persons mentioned in RTI application in their respective jurisdiction.

Comments of CPIO/South-West :-

So to proceed further in the matter comments of CPIO/South-west have been obtained who submitted that RTI application of the appellant was received in his office through Nodal Officer RTI PHQ Sector 9, Chandigarh vide No. 442/RTI/CAPIO(PHQ)/UT/PWS, dated 26.05.2022. Thereafter, requisite information was obtained from all the SHOs of South-west Sub Division and in reply SHO PS-36 and Maloya reported that no FIR/DDR found registered against the persons mentioned in RTI application whereas SHO PS 39 supplied copy of one FIR No. 160 dated 28.05.2017 u/s 448,427,34 IPC PS 39 Chandigarh registered on the complaint of the appellant (consisting 6 pages) and rest of the information denied u/s 8(1)(h)&(j)of RTI Act. The appellant was informed accordingly vide letter no. 80-RTI/CPIO/South-West dated 22.06.2022.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that initially the RTI application of the appellant was received in the office of Nodal Officer RTI, PHQ Sector 9 Chandigarh on 25.05.2022 who transferred the same RTI application to CPIO/Central, East, North-East, South, South-West and W&CSU vide letter No. 442/RTI/CAPIO(PHQ)/UT/PWS, dated 26.05.2022. In reply, available information was supplied to the appellant by all these CPIOs including CPIO/South-West, who supplied the copy of FIR No. 160 dated 28.05.2017 u/s 448, 427, 34 IPC PS 39 Chandigarh registered on the complaint of the appellant (consisting 6 pages) and denied the remaining information u/s 8(1)(h)&(j) of RTI Act as other cases were under investigation and treating the same as personal information of other persons, being no relation to the appellant, disclosure of which having no relationship to any public activity or interest.

As the available information has already been provided to the appellant by CPIO/South-West, hence, no more action is warranted in the instant appeal and the same stands disposed off, accordingly. So far as grievances of the appellant raised in the instant appeal are concerned, that cannot be entertained under RTI Act as this act provides a mechanism for seeking/providing information to the appellant but it is not an appropriate platform/forum for redressing his grievances.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
