ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/20/00010 dated 23.01.2021) against the reply/order of CPIO/ South in connection with her RTI application (bearing No. PODEP/R/E/21/00618 dated 05.12.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 09/UT/RTI/FAA/SSP dated 25.01.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copies of DDRs dated 23.03.2019 lodged in PP-Burail with regard to FIR No. 284/2018, PS-34, UT, Chandigarh.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that appellant has sought information through online RTI application. After obtaining report from SHO/PS-34,

requisite information i.e. copy of DDR No. 30 & 33 dated 22.03.2019 in PP-Burail was supplied to the appellant vide No. 516/CPIO/South dated 01.01.2021. At present, no information is left for supplying to appellant, hence, his appeal may be filed, please.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copies of DDRs dated 23.03.2019 lodged in PP-45 with regard to FIR no. 284/2018, PS-34, UT, Chandigarh.

It is clear from the perusal of RTI application, appeal as well as the reply of the CPIO/South that requisite information has already been supplied to the appellant and now in appeal; he has raised his grievances which cannot be redressed under RTI Act as RTI Act only provides mechanism for furnishing requisite information. Hence, CPIO/South had appropriately disposed of RTI application and no more action is warranted, thus, instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
