**ORDER**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on the online first appeal bearing No. PODEP/A/E/22/00052 dated 15.05.2022, preferred by Manish Kumar r/o H. No. 554, New Police Line, Sector-26, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System(RTI-MIS), against the disposal of his RTI Application bearing No. PODEP/R/E/22/00215 dated 29.03.2022 by CPIO/Communication.

2) The appellant, vide his RTI application dated 29.03.2022 under RTI Act 2005, had requested, CPIO/Communication to supply him some information in 02 points, about the purchases made by the Communication Wing. CPIO/Communication disposed-of the RTI application, vide No. RTI-25/DSP/Comn./UT, dated 26.04.2022.


3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal alleging that the CPIO/Communication has failed to supply on point No. 1(B) of the RTI application.

4) The comments of DSP-cum-CPIO/Communication have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by the CPIO. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
