ORDER

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00112 dated 30.09.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00751 dated 29.08.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 29.08.2023 had sought information on 09 points pertaining to complaint No. PW2022-11386 i.e. name & designation of I/O, certified copy of DDR, sequential proceedings of complaint, details of organizations & persons contacted for enquiry, certified copy of documents, copy of statements, details of his RTI applications & replies etc.

Comments of CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from CPIO/South-West for supplying information pertaining to complaint bearing Nos. PW2022-11386. After obtaining the current status of relevant complaint, requisite information was obtained from concerned branch (HAC branch) and the appellant was informed to collect the same from the office of CPIO/Hqrs vide letter No. 272/CPIO/Hqrs/Online RTI-2023 dated 11.09.2023. Thereafter, appellant collected the available information consisting of 320 pages after inspection of relevant complaint file vide letter/receipt Nos. 272-280/CPIO/Hqrs/Online RTI-2023, D-273 dated 13.10.2023 & 17.10.2023.

Decision :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant had sought information on 09 points pertaining to complaint bearing No. PW202211386 i.e. name & designation of I/O, certified copy of DDR, sequential proceedings of complaint, details of


organizations & persons contacted for enquiry, certified copy of documents, copy of statements, details of his RTI applications & replies etc.

In reply, CPIO/Hqrs supplied the available information consisting of 320 pages to the appellant after arranging inspection of the relevant record and also provided point wise reply to the appellant.

In view of above, it is amply clear that available information at the disposal of CPIO, has already been supplied to the appellant under proper receipt. Henceforth, no more action is required to be taken in the matter.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
