#### **ORDER**

The appellant has preferred her online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00114 dated 04.10.2023 against the disposal of her online RTI application bearing No. PODEP/R/E/23/00755 dated 29.08.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

## Information sought vide RTI application :-

The appellant vide her online RTI application dated 29.08.2023 had sought certified copy of evidence given by me regarding my complaint bearing No. PW2021-15513.

### COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. As per record complaint bearing No. PW202115513 was found consigned with HAC branch after completion of enquiry. Thereafter, requisite complaint file was obtained from quarter concerned and the appellant was requested telephonically and as well as vide letter No. 275/CPIO/Hqrs/Online RTI-23, D-223 dated 18.09.2023 to inspect the relevant record and collect the same as per RTI act but she did not turn up to collect the requisite information.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant

vide her RTI application has sought certified copy of evidence given by her regarding her complaint bearing No. PW202115513.

In reply, CPIO/Hqrs obtained the requisite complaint file from the concerned branch and informed the appellant to inspect the relevant record and collect the same as per RTI act but she did not turn up to collect the requisite information.

So far as the appeal is concerned, the appellant was already informed by CPIO to collect the sought information from his office after depositing the requisite fee under RTI act. But the appellant did not turn up to collect the same. So, appellant is hereby advised to collect the requisite information from the office of CPIO/Hqrs as per RTI act without any delay. Hence, no more action is required to be taken on the instant appeal and the same stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
