ORDER

The appellant has preferred 1st appeal through online RTI portal vide No. PODEP/A/E/22/00140 dated 23.11.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00870 dated 04.11.2022 with the contentions that incomplete, misleading and false information has been provided to him.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 04.11.2022 had sought information on 03 points pertaining to a complaint bearing No. ICMS/2022/005221 dated 04.08.2022.

COMMENTS OF CPIO/Hqrs :-

Comments of CPIO/Hqrs have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00870 dated 04.11.2022 for seeking information on 03 points pertaining to a complaint bearing No. ICMS/2022/005221 dated 04.08.2022. In this regard, requisite information was sought from I/C CRU who reported that complaint in question is under consideration with senior officers, hence, the information was denied to the appellant u/s 8(1)(h) of RTI Act. The appellant was informed online accordingly vide letter No. 324/CPIO/Hqrs/Online/RTI-22/D-180 dated 11.11.2022.


DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqs vis-à-vis material available on record which revealed that the requisite information was denied to the appellant by CPIO/Hqs u/s 8(1)(h) of RTI Act as the complaint bearing No. ICMS/2022/005221 dated 04.08.2022 was under consideration with senior officer in Police Headquarters at that time. Hence, the undersigned is agree with the decision of CPIO/Hqs.

So far as the present status of the complaint in question is concerned, as per record of Public Window System, the same is sent back to SDPO-cum-CPIO/North-East for further enquiry, hence, complete requisite information cannot be supplied at this stage also, hence, denied u/s 8(1)(h) of RTI Act. Yet, in the interest of justice, copy of complaint and name & designation of the Enquiry Officer can be supplied to the appellant.

In view of above, CPIO/North-East is hereby directed to supply the copy of complaint and name & designation of enquiry officer to the appellant as per RTI Act. With these observations, the instant appeal stand disposed off.

However, in case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
