# **ORDER**

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00110 dated 27.09.2023 against the disposal of her online RTI application bearing No. PODEP/R/E/23/00781 dated 06.09.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to her.

## Information sought vide RTI application :-

The appellant vide his RTI application dated 27.09.2023 had sought certified copy of complaint bearing No. ICMS/2023/008494.

## COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding complaint bearing No. ICMS/2023/008494. Thereafter, requisite information was obtained from I/C CRU who reported that complaint in question is under consideration for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 281/CPIO/Hqrs/Online RTI-2023, D-225 Dated 20.09.2023.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought certified copy of complaint bearing No. ICMS/2023/008494.

In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaint in question was under consideration at that stage.

So far as the appeal is concerned, the appellant has mentioned wrong and incorrect complaint number i.e. ICMS/2023/008494 (filed by someone namely Suraj Sharma) in his 1st appeal and RTI application. Accordingly, RTI application was wrongly dealt by CPIO/Hqrs. The complainant should have mentioned correct complaint Number i.e. ICMS/2023/018494 which is currently under enquiry with DSP/W&CSU.

Hence, in the interest of justice and to uphold the spirit of RTI Act, CPIO/W&CSU is hereby directed to supply the requisite information i.e. copy of complaint No. ICMS/2023/018494 to the appellant as per RTI act. Appellant is also advised to visit the office of CPIO/W&CSU for requisite information.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
