## ORDER

The appellant has preferred 1<sup>st</sup> appeal dated 13.09.23 (received on 21.09.23) against the disposal of his RTI application dated 24.07.2023 by CPIO/North-East with the contentions that requisite information was not provided to him.

## Information sought vide RTI application :-

The appellant vide his RTI application dated 24.07.2023 had sought information on 04 points regarding case FIR No. 15 dated 18.03.2023 registered at Police Station IT Park, Chandigarh i.e. copy of Medical reports (MLR) of injured persons in the above mentioned FIR, copy of all statements recorded and copy of all other related documents which are part of the investigation etc.

## COMMENTS OF CPIO/North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding case FIR No. 15 dated 18.03.2023 registered at Police Station IT Park, Chandigarh. Thereafter, requisite information was obtained from SHO PS- IT Park who reported that FIR in question is still under investigation. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 123/ RTI/GPIO/North-East/ Chandigarh dated 27.07.2023.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 04 points regarding case

FIR No. 15 dated 18.03.2023 registered at Police Station IT Park, Chandigarh i.e. copy of Medical reports (MLR) of injured persons in the above mentioned FIR, copy of all statements recorded and copy of all other related documents which are part of the investigation etc.

In reply, CPIO/North-East rightly denied the requisite information u/s 8(1)(h) of RTI Act as case FIR No. 15 dated 18.03.2023 registered at Police Station IT Park, Chandigarh was under investigation at that time.

So far as the appeal is concerned, case FIR No. 15 dated 18.03.2023 registered at Police Station IT Park, Chandigarh is still under investigation so, investigation details of the case which were sought by the appellant i.e. Medical reports, statements recorded and other documents/evidences, cannot be disclosed at this stage also. Hence, denied u/s 8(1)(h) of RTI Act. However, CPIO/North-East is hereby directed to cooperate with the appellant and verbally apprise him about the progress of the aforementioned case. Appellant is also directed to approach the CPIO/North-East for the current status of case in question.

Moreover, appellant has attached a postal order of Rs. 10 with his 1<sup>st</sup> appeal, which is not required. The same is attached herewith and sent to you in original.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
