ORDER

The appellant has preferred 1st appeal dated 08.09.2023 against the disposal of his RTI application dated 22.07.2023 by CPIO/W&CSU with the contentions that requisite information was not provided to him. The instant 1st appeal was received from FAA-cum-SP/W&CSU.

Information sought vide RTI application :-

The appellant vide his RTI application dated 22.07.2023 had sought information on 11 points regarding complaint No. ICMS/2022/013866 dated 21.11.2022 i.e. current status of complaint, diary number when complaint was marked to PS Maloya, Name of I/O, Is I/O recorded the statement of Preeti, certified copy of statement & enquiry report etc.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from CPIO/South-West to supply the information regarding complaint No. ICMS/2022/013866 dated 21.11.2022. Thereafter, requisite information was obtained from concerned branch and the same (consisting of 07 pages) was received by the appellant after inspecting the relevant complaint file on 23.08.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 11 points regarding complaint No. ICMS/2022/013866 dated 21.11.2022 i.e. current status of complaint, diary number when complaint was marked to PS Maloya, Name of I/O, Is I/O recorded the statement of Preeti, certified copy of statement & enquiry report etc.

In reply, CPIO/Hqrs obtained the requisite information from the quarter concerned and supplied the same (consisting of 07 pages) to the appellant after inspection of the relevant complaint file.

So far as the appeal is concerned, CPIO submitted that appellant has already received the available information in the shape of 07 pages yet he has raised some objections regarding non-supplying of some documents like complete statements recorded by I/O etc. So, in the interest of RTI act and for the satisfaction of the appellant, CPIO/Hqrs is hereby directed to arrange the inspection of the relevant complaint file once again and supply the remaining information, if any, to the appellant as per RTI act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
