### **ORDER**

The appellant has preferred his 1<sup>st</sup> appeal bearing dated 04.10.2023 against the disposal of his RTI application dated 14.09.2023 by CPIO/Hqrs with the contentions that requisite information was not supplied to him.

## Information sought vide RTI application:

The appellant vide his RTI application dated 14.09.2023 had sought action taken report and all statements pertaining to complaint No. ICMS/2023/011386 dated 14.09.2023.

#### Comments of CPIO/Hgrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Accordingly, requisite information was obtained from I/C HAC who reported that complaint No. ICMS/2023/011386 dated 14.09.2023 has been sent to the O/o Director General of Police, Punjab Police Headquarters, Sector 09, Chandigarh vide letter No. 6436/UT/HAC dated 14.09.2023 for taking further necessary action at their own end. So, requisite information could not supplied to the appellant and he was advised to approach the concerned SPIO of Punjab Police vide letter No. 546/CPIO/Hqrs/ RTI-23, D-681 dated 20.09.2023.

#### Decision:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant had sought action taken report and all statements regarding complaint No. ICMS/2023/011386 dated 14.09.2023.

In reply, CPIO/Hqrs has apprised the appellant that complaint bearing No. ICMS/2023/011386 dated 14.09.2023 alongwith all relevant documents, has already been

ent to the O/o Director General of Police, Punjab Police Headquarters, Sector 09, Chandigarh, hence, requisite information could not supplied to him and the same may be obtained from the concerned SPIO of Punjab Police.

So far as the appeal of the appellant is concerned, the appellant has already been apprised by CPIO/Hqrs that his complaint alongwith all relevant documents, has already transferred to the Office of DGP, Punjab Police, so, he should approach the concerned SPIO of Punjab Police for requisite information as requisite information is currently not under the custody of CPIO/Hqrs. Moreover, CPIO/Hqrs is hereby directed to supply the copy of transferring letter to the appellant in accordance with RTI act. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
