ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 10/UT/RTI/FAA/SSP dated 02.02.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on three points pertaining to FIR No. 127 dated 24.4.2015, PS-17, Chandigarh.

COMMENTS OF CPIO/CENTRAL: -

CPIO/Central submitted that appellant has sought information RTI application and thereafter report from SHO/PS-17 was obtained who reported that FIR No. 127 dated 24.4.2015, PS-17 was under investigation at that time, therefore, same was denied u/s 8(1)(h) of RTI Act. As far as appeal is concerned, said FIR is still under investigation and the

same could not be supplied at present. Hence, appeal may be filed, please.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on three points pertaining to FIR No. 127 dated 24.4.2015, PS-17, Chandigarh

CPIO/Central has contended that case FIR No. 127 dated 24.04.2015, PS-17 is still under investigation and the same could not be supplied at this stage u/s 8(1)(h) of RTI Act. Insofar appeal is concerned; appellant wants status/progress of investigation of aforesaid case FIR, the same can be apprised to the appellant.

In view of above, CPIO/Central is hereby directed to apprise appellant about the current status of the case FIR and also apprise him about the progress of case. Appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
