Subject: - **Inviting applications for the allotment of various categories of Police Pool Houses.**

Applications for fresh allotment of various types of Police Pool houses are invited from the eligible police personnel/officials. The desirous applicants may submit their applications in **Form-I** (available at Police Headquarters Reception and also on the Chandigarh Police Website) duly filled in by **31.03.2013**. The entitlement of each category has been shown in **Annexure-'A'** appended on the reverse of the **application Form-I**.

2 Those, who are already in occupation of Govt. accommodation of lower category than their entitlement as at **Annexure-A**, but want higher type as per entitlement should also submit their applications in Form-I for fresh allotment.

3 For the fresh allotment of type-I/13, the applications will be accepted from Constables/Head Const./Steno/Jr.Asstt./Clerk/Class-IV recruited on or before **31.12.2003**. However, for fresh allotment of type-II/12 Head Constable/Steno/Jr. Asstt & Constables with service of 18 years will be eligible to apply.


4 An officer/official can apply for one category of house only to which he is entitled as per **Annexure-'A'**. Application Form submitted for allotment of house other than the entitled category would automatically stand rejected.

5 The office shall process all the applications of the eligible employees, so received and a tentative seniority list of the applicants shall be prepared by **18.04.2013**. The tentative seniority list will be made available at Police Headquarters (UT) Sector-9, Chandigarh as well as at all the Police Stations and Police Lines besides on Chandigarh Police Website for checking and satisfaction of all the applicants, inviting claims and objections, if any, within seven days. Objection received thereafter shall not be entertained. Final seniority list shall be prepared after considering the objections by **25.04.2013**.

6 The officers/officials who had earlier applied and whose names already exist in the seniority list of the year-2012, but have not been allotted house, **need not to apply afresh**, as their names will be merged in the new/revised seniority list.

7. Eligible Ex Service-men who are serving in Police Department may also submit their applications in **Form-II** (available at Police Headquarters Reception and also on the Chandigarh Police Website) duly filled in. The entitlement of each such official/s will be adjudged after adding the service rendered by him/them in defense services excluding break in service. The preference of sector/floor will not be entertained for fresh allotment.

8. All In-charge units will ensure that the circular is displayed immediately on the Notice Board of the units.
