### CIRCULAR

Subject:-

Inviting applications/willingness for the allotment of Type-II Police Pool Houses {newly constructed} in Police Complex- Dhanas, Chandigarh.

The construction of 336 Police Pool Houses of Type-II (Phase-I) in Police Complex, Dhanas has been completed by the Engineering Department and the possession of these houses are being taken over, so that houses could be allotted to the eligible police personnel/employees. Therefore, applications in shape of willingness form for the allotment of these Type-II Houses are hereby invited from the entitled category i.e. Stenos/Jr. Asstt/Head Constables (1st preference) and Constables/Clerks (2<sup>nd</sup> preference) who are confirmed, as such. The desirous applicants may submit their applications in the prescribed proforma/willingness Form (specimen attached, also available on official website of Chandigarh Police, Quarter Branch and at Police Headquarters Reception) by **26.11.2021** (Friday).

2. Those Stenos/Jr. Asstt/Head Constables (1st preference) and Constables/Clerks (2<sup>nd</sup> preference), who are confirmed as such, may apply and submit willingness for the allotment, but priority will be given to those Constables/Clerks who have completed minimum 12 years of service. Those eligible officials who are already in occupation of government accommodation of lower category i.e. Type-I/13 (except to whom out of turn allotment is made) and want to shift in Type-II Police Pool Houses in Police Complex, Dhanas should also submit their willingness in the prescribed form. Similarly, those Stenos/Jr. Asstt/Head Constables (1st preference) and Constables/Clerks (2<sup>nd</sup> preference) already having Type-II houses in other Sectors and want to shift in Police Complex, Dhanas (except to whom out of turn allotment is made) should also apply in the

enclosed prescribed proforma/willingness form. No willingness form shall be entertained

after said fix date.
