**ORDER**

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00075 dated 07.08.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00605/1 dated 18.07.2023 by CPIO/South-West and PCR with the contentions that requisite information were not provided to him.

**INFORMATION SOUGHT VIDE RTI APPLICATION :-**

The appellant vide his online RTI application had sought information on 02 points i.e. whether the statement given by ASI Jaswinder mentioned in letter No. RTI-08/DSP/PCR/UT Chandigarh is correct that there were labourers in the pictures instead of Advocate Arun Vohra, Aarti Vohra and List of items prepared by ASI Jaswinder on the spot regarding the household articles taken away by Advocate Arun Vohra, Aarti Vohra without the orders of Hon'ble President, Hon'ble PM, Hon'ble CJI etc.

**COMMENTS OF CPIO/PCR :-**

CPIO/PCR vide his comments submitted that RTI application of the appellant was received in his office vide No. PODEP/R/E/23/00605/1 dated 18.07.2023 to supply the requisite information. Accordingly, after obtaining requisite information from the quarter concerned, the same was provided to the appellant in point wise manner vide letter No. RTI-14/DSP/PCR/UT, Chandigarh dated 26.07.2023.

**COMMENTS OF CPIO/SOUTH-WEST :-**

CPIO/South-West vide his comments submitted that RTI application of the appellant was received in his office vide No. PODEP/R/E/23/00605 dated 18.07.2023 for supplying requisite information. On perusal of RTI application, it has been revealed that the applicant has sought information pertaining to letter No. RTI-08/DSP/PCR/UT Chandigarh which primarily related with CPIO/PCR. Moreover, RTI application has already been transferred to CPIO/PCR through online RTI portal. Hence, no action is warranted on the part of CPIO/South-West. The appellant was informed accordingly vide letter No. 162-RTI/CPIO/South-West dated 25.07.2023.



**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PCR vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 02 points i.e. whether the statement given by ASI Jaswinder mentioned in letter No. RTI-08/DSP/PCR/UT Chandigarh is correct to the effect that there were labourers in the pictures instead of Advocate Arun Vohra, Aarti Vohra and list of items prepared by ASI Jaswinder on the spot regarding the household articles taken away by Advocate Arun Vohra, Aarti Vohra without the orders of Hon'ble President, Hon'ble PM, Hon'ble CJI etc.

In reply, CPIO/South-West informed the appellant that requisite information relates to CPIO/PCR and RTI application has already been transferred to CPIO/PCR through online RTI portal.

CPIO/PCR had provided the sought information to the appellant in point-wise form.

So far as the appeal is concerned, the appellant has raised his grievances regarding the identities of the persons shown in the pictures and the allegations of help provided by police officer shown in the pictures to that persons etc. which are not covered under the purview of RTI act. Only available information can be obtained under RTI act which was already provided to the appellant by CPIO/PCR. Moreover, the appellant wants to elicit the correctness of some facts/questions from his own point of view through his RTI application and appeal which is not maintainable under RTI act. In order to address his grievances, he should approach appropriate competent authority or appropriate legal platform. Henceforth, no more action is warranted in the matter.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
