ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 112/UT/RTI/FAA/SSP dated 13.10.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought certified copy of action taken report on the orders passed by Hon'ble PCA in complaint No. 1 of 2019.

COMMENTS OF CPIO/PHQ:

CPIO/PHQ submitted that RTI application of the appellant was received online vide No. PODEP/R/E/20/00406 dated 04.09.2020 for supplying the requisite information. Thereafter, report from I/C PCA & Monitoring Cell was obtained, accordingly, appellant was informed vide letter No. 128/DSP/Hqrs/RTI-2020, D-123 dated 18 & 23.09.2020.

DECISION:


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought certified copy of action taken report on the orders passed by Hon'ble PCA in complaint No. 1 of 2019.

CPIO/PHQ had informed about the status of Action Taken Report on the orders of Police Complaint Authority, UT Chandigarh.

So far as the appeal is concerned, appellant has raised his grievances pertaining to his complaint lodged in PCA, UT, Chandigarh which is not under the purview of RTI act. However, CPIO/PHQ had informed the appellant about the status of Action Taken Report against the delinquent Police Officials i.e. Departmental Action is under process. Hence, no more action is required to be taken in the instant appeal and the same is hereby disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
