Allotment cycle No. 18th - Inviting applications for fresh/ Change houses of all categories of Police Pool Houses up to 20.08.2018.

Applications are hereby invited from the eligible & willing employees of Chandigarh Police as per Standing Order for fresh/change allotment of police pool houses (Except Constables, Clerks, Class-IV employees who joined Chandigarh Police after 31.12.2008) on the prescribed performa (Specimen available on the website of Chandigarh Police i.e. www.chandigarhpolice.nic.in) duly filled and forwarded by the concerned G.O by 20.08.2018. The applications reached/diarized in the diary section of PHQ by 20.08.2018 will be entertained in the present cycle of allotment and the applications received/diarized after 20.08.2018 will be entertained during the next cycle of allotment.

No request for change of choice of sector/change of house/withdrawal of application will be entertained after the due date 20.08.2018 in the 18th cycle and houses available vacant up to 31.08.2018 will be considered in this cycle of allotment. Applications received after 20.08.2018 and houses received vacant after 31.08.2018 will be considered in next cycle i.e. 19th cycle.

## FORM NO.1

The employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.1.

## FORM NO.2

Only Ex-servicemen employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.2.

## FORM NO.3

Only the employees who are in occupation of police pool house and wants to change in the same category of house may apply on Form No.3.

An officer/official can apply for one category of house only to which he is entitled. Application Form submitted for allotment of house other than the entitled category would automatically stand rejected. The employees whose name already stands in the seniority lists maintained for the purpose of fresh allotment/change of house in the office, need not to apply again.
