Subject: - **ALLOTMENT CYCLE NO.3 - Inviting applications for fresh allotment / change of various categories of Police Pool Houses.**

It is brought to the notice of employees of Chandigarh Police that W/IGP has issued New Standing Order on House Allotment of Chandigarh Police vide No.59/UT(-5) dated 9.12.2013 in suppression of old Standing Order No.7041/UT/E-3 dated 10.03.2003. As per this Standing Order all the old seniority lists maintained for the purpose of allotment/change of police pool houses prior to 09.12.2013 have been cancelled and new seniority lists have been prepared as per applications received vide new circular dated 29.01.2014. Allotment process has also been started as per new seniority lists.

In view of above, applications are invited from the eligible employees of Chandigarh Police as per new Standing Order for fresh allotment/change of houses. The desirous employees may submit their applications on the prescribed performa (Specimen enclosed and also available on the website of Chandigarh Police i.e. www.chandigarhpolice.com) duly filled and forwarded by the concerned G.O by 15.07.2014. The applications reached/diarized in the dairy section of PHQ by 15.07.2014 will be entertained in the present cycle of allotment and the applications received/diarized after 15.07.2014 will be entertained during the next cycle of allotment.

FORM NO.1

The employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.1.

FORM NO.2

Only Ex-servicemen employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.2.

FORM NO.3

Only the employees who are in occupation of police pool house and wants to change in the same category of house may apply on Form No.3.

The entitlement of each category has been shown in **Annexure-'A'** appended on the reverse of the **application Form**.

An officer/official can apply for one category of house only to which he is entitled as per **Annexure-'A'**. Application Form submitted for allotment of house other than the entitled category would automatically stand rejected. The employees whose name already stands in the seniority lists maintained for the purpose of fresh allotment/change of house in the office, need not to apply again.
