Subject:- Inviting objections regarding seniority list /options regarding choice of sector for allotment of various Type of Police Pool Houses.

1. INVITING OBJECTIONS REGARDING SENIORITY LIST

In response to this office circular issued vide No.5963-69/UT/E-5(Qtrs) dated 17.04.2014, vide which office has invited applications from the employees of Chandigarh Police for the allotment of various type of Police Pool Houses. Total 335 applications of various categories have been received in the office till 30.04.2014. While scrutiny of these applications 272 applications are found to be correct and 63 applications were rejected being not fulfilling the conditions as per New Standing Order on House Allotment of Chandigarh Police. As such, 272 eligible candidates have been merged in the previous seniority lists and draft seniority lists of eligible candidates have been prepared (copy enclosed) and hereby placed on the website of Chandigarh Police i.e. www.chandigarhpolice.nic.in for inviting objections from these eligible candidates.

2. INVITING OPTIONS FOR CHOICE OF A SECTOR

W/GP has issued amendments regarding New Standing Order vide order No.8549/UT/E-5(Qtrs) dated 20.05.2014 (placed on the website of Chandigarh Police i.e. www.chandigarhpolice.nic.in) that the employees can give his choice of a sector in Chandigarh (and not any particular building) and his request will be considered strictly as per the seniority list and availability of Govt. Quarters i.e. if two officials have made a request for a house in a sector and only one house is available there, then the request of officer higher on the seniority list will be accepted, if otherwise eligible. Expression of choice of a sector by the applicant will not confer any right of allotment at that particular sector. Allotment will be made depending upon the availability of Govt. quarters and on seniority basis strictly.

The objection/options, if any, must reach in the House Allotment Branch, 3rd floor, PHQ Building, Sector-9, Chandigarh with in 2 weeks from the date of issue of this circular i.e. 05.06.2014. After receipt of objections/options, final seniority list will be prepared and the allotment process will be completed as per New Standing Order on House Allotment of Chandigarh Police. The objections/options must be reached/diarized in the dairy section of PHQ by 05.06.2014.
